Description

The Flexible Hoses are manufactured of stainless-steel braided hose.

They come in 15mm Female BSP thread, and unit lengths of 150mm-1000mm.

The Flexible Hoses are rated 8 Bar suitable for use to transmit hot water up to a maximum temperature of 80°C.

Scope of use

The Flexible hoses can be used in residential and small commercial applications systems for the supply of hot and cold potable water up to 80°C. has a durability of less than 50 years – meaning it is not suitable to be placed behind concrete and other permanent structures.

Conditions of use

The Flexible hoses as a plumbing component must be installed by a registered plumber following the installation instructions of the main appliance that the Flexible hoses are being used with.

Contributions to compliance

B2.3.2 The Flexible hoses, with only normal maintenance, continue to satisfy the performance requirements of this code.

F2.3.1 The Flexible hoses are safe when handled. There are no requirements for this product to comply with Acceptable Solution F2

G10.3.1 The Flexible hoses are manufactured to avoid the likelihood of significant leakage or damage during normal or reasonably foreseeable abnormal conditions, detrimental contamination of the contents by other substances, adverse interaction between services, or between piping and electrical systems, and people having contact with pipes which could cause them harm.

G12.3.2 / G12.3.7 The Flexible hoses are protected from contamination; and installed in a manner that avoids the likelihood of contamination within the system and the water main; and installed as a component that will not contaminate the water. The Flexible hoses are manufactured to AS/NZS 3500 standards and avoids the likelihood of leakage; and allows reasonable access to components likely to need maintenance.
